FILM AND PHOTO CONSENT FORM

Teen Court regularly distributes a brochure describing the program that includes photographs of student volunteers. These brochures are provided to Teen Court partners, funders, community leaders and other interested parties. In addition to the brochure, from time to time Teen Court videotapes court sessions to be used for training or to include with grant funding applications. During March and April 2008 we are working with the Del Mar TV Foundation to produce a documentary on Teen Court that will be aired on County Access Television in San Diego. If agreeable to participate in the photographs and videos for Teen Court, please sign this release form to provide your consent. You may have a copy of our brochure and video upon request.

In connection with my participation in Teen Court, I agree as follows:

1. In consideration of the below named student's participation in Teen Court, and upon the terms hereinafter stated, I hereby grant to San Diego Teen Court, SAY San Diego, and its officers, employees, agents, legal representatives and assigns, the absolute right and permission to copyright and use, re-use, publish, and re-publish photographic pictures, video and/or film of the student or in which the student may be included, in whole or in part, without restriction as to reasonable changes or alterations from time to time, in conjunction with the student's own or a fictitious name, or reproductions thereof in color or otherwise.
2. I understand that first and last names of adult and student volunteers who are not defendants in a Teen Court proceeding may be disclosed, but that my address, telephone number or any type of other personal information about me or my family will not be revealed or disclosed for any purpose connected with Teen Court photographs or videos.
3. I hereby waive any right that I or the student may have to inspect or approve the finished product or products or printed matter that may be used in connection therewith or the use to which it may be applied.
4. I hereby release, discharge, and agree to hold harmless the San Diego Teen Court, its employees, volunteers, representatives, officers, directors, agents, licensees, predecessors, successors and assigns, as well as any affiliated company, government agency or associated organizations from any and all claims for violation of my right to privacy or of any other nature whatsoever relating to my appearance in Teen Court photographs and videos.
5. I hereby warrant that I am over the age of majority and have every right to contract for the student in the above regard. This release shall be binding upon me and my heirs, legal representatives and assigns.
6. I understand and agree that I have been fully informed of all my rights and that I have been given the opportunity to seek independent counsel to answer all questions which I may have or have had concerning my rights and that all of these questions have been answered to my satisfaction.
